Dear Colleague:

I am pleased to provide you with the 1996-97 Annual Survey Report of the National Association of State Student Grant and Aid Programs (NASSGAP).

The Report chronicles the variety of need-based and merit-based aid provided by states to undergraduates and graduates for both full-time and part-time study. Overall student aid expenditures by the collective states increased by 6.1 percent in 1996-97 with more than two million students served. However, the growth rate for need-based undergraduate student aid was 4.1 percent less than the 10 percent average for the past five years, possibly a reaction to the 50% reduction in federal funding for the SSIG matching program. The continuation of the SSIG and other partnership programs with the federal government, such as Robert C. Byrd Honors Scholarship and the National Early Intervention Scholarship and Partnership (NEISP) Program, are essential in maintaining access to higher education for all students who can benefit.

I want to thank the New York State Higher Education Services Corporation for conducting the Report survey and compiling the results.

Executive Summary

The National Association of State Student Grant and Aid Programs (NASSGAP) is pleased to present its 28th Annual Survey Report of state-administered student financial aid available for the 1996-97 academic year.

This year's report, the third compiled and published by the New York State Higher Education Services Corporation (HESC), offers information and statistics such as basic program information and expenditures, longitudinal indicators of student aid funding, and comparisons of student financial aid available in each of the 52 states and territories (Washington, D.C. and Puerto Rico included) and the Nation. The data and tables contained in the Report represent actual 1996-97 academic year data.

Federal funding of the State Student Incentive Grant (SSIG) Program was severely decreased for the 1996-97 academic year. Federal funding for this program went from \$63.4 million in the 1995-96 academic year to \$31.4 million in the 1996-97 academic year, a \$32 million or 50% loss. The SSIG program is a dollar-for-dollar federal/state matching program designed to enable states to offer need-based grant aid to students to attend postsecondary education institutions. A loss in SSIG funding negatively affects need-based grant programs in all states, though the 3-year average "maintenance-of-effort" requirement will delay the full statistical impact on state program spending.

Student Aid Highlights

- ◆ In the 1996-97 academic year, the states awarded \$3.090 billion in need and non-need based student grant aid to more than two million students, an increase of 6.1% in expenditures over the \$2.914 billion awarded in 1995-96. Of the amount awarded, 84% was need-based grant aid to undergraduate and graduate students, while 16% of it was non-need-based grant aid to undergraduates and graduates. These percentages vary slightly from the 85% and 15% awarded, respectively, in 1995-96.
- ◆ Funding for undergraduate need-based grant aid increased only slightly in the 1996-97 academic year, increasing 4.1% from 1995-96, showing the early impact of reduced federal SSIG program funding. It had increased an average of 10.0% yearly over each of the previous five academic years (see Table Nine).
- ◆ Of the \$2.6 billion in need-based grant aid available, 99% went to undergraduates; and, of the \$0.5 billion in non-need-based grant aid awarded, 94% was awarded to undergraduates.
- ◆ Five states (California, Illinois, New Jersey, New York, and Pennsylvania) collectively awarded \$1.6 billion in undergraduate need-based grant aid, comprising 60% of the total awarded in this category.
- ◆ Over the past five years, state spending (in current dollars) on need and non-need based grant aid to undergraduate and graduate/professional students has increased 52.2% (see Table Two). From 1995-96 to 1996-97, 81% of the states (42) reported an increase in these categories, while only 19% (10) reported a decrease.
- ◆ Thirteen states reported an increase in need-based grant aid to undergraduates of more than 10% over 1995-96. These states were Arizona (+ \$0.46 million), Arkansas (+ \$1.80 million), Colorado (+ \$7.16 million), Indiana (+ \$9.49 million), Kentucky (+ \$2.69 million), Maryland (+ \$5.91 million), Missouri (+ \$1.45 million), Nevada (+ \$0.59 million), North Dakota (+ \$0.30 million), Oregon (+ \$2.59 million), Tennessee (+ \$2.92 million), Utah (+ \$0.97 million), and West Virginia (+ \$2.39 million). Nine states reported a decrease in funding of more than 10%. These states were Alaska (- \$0.22 million), Delaware (- \$0.23 million), Hawaii (- \$0.12 million), Georgia (- \$2.59 million), Mississippi (- \$0.63 million), Montana (- \$0.08 million), New Hampshire (- \$0.10 million), South Dakota (- \$0.22 million), and Wyoming (- \$0.06 million).
- ◆ Reporting agencies also administered nearly \$9.5 billion in other aid (e.g., student loans, work-study, scholarships - see Table Three).

Comments to Better Understand Agency Responses, 1996-97

Arizona

The State Student Incentive Grant Program distributed awards in 1996-97 totaling \$2,748,793 consisting a federal portion of \$543,244, a state portion of \$1,220,800 and an institutional portion of \$984,749.

The Arizona Postsecondary Education Voucher Program was implemented in the Spring of 1997. This program offers \$1,500 vouchers per academic year, for a period of two years or a total of \$3,000 for public community college graduates. Students must register full time and attend a licensed and accredited independent four-year institution to qualify for the voucher.

The Arizona Family College Savings Program is scheduled to be implemented in March 1998. Three financial institutions have been awarded state contracts. The Program is currently only one of two savings plans nationwide that partners the private and public sectors. In addition, the State of Arizona does not levy taxes on the interest earned by participants of the program.

California

The California Student Aid Commission received \$20 million in new funds in the 1996-97 State Budget to expand the Cal Grant Programs. \$10 million of the new funding amount was allocated to increase the maximum award levels for new (first-time) 1996-97 Cal Grant A and B recipients attending independent colleges and proprietary schools. The additional funds will increase the maximum award to \$7,164. The last time the maximum award was increased for the Cal Grant A and B programs was for the 1989-90 academic year.

The remaining \$10 million increase funded approximately 5,400 additional new awards, for a total of 36,693 new awards in the Cal Grant Programs. Academic year 1989-90 was the last time that the number of authorized new awards had been increased.

The BIG story for 1996-97, however, was the creation of EDFUND. On January 1, 1997, the California Student Aid Commission introduced EDFUND, a new provider of student loan services. EdFund is the Commission's new nonprofit corporation offering the Federal Family Education Loan Program to California students attending both in-state and out-of-state schools.

Colorado

This year we are reporting Diversity as "need-based". Schools may still make awards to non-need students, but over 80% of all funds must be awarded to need-based students.

Delaware

Merit-based increase for SeIP restricted to undergraduates attending colleges in Delaware only.

Illinois

State Student to Student Program funds are allocated as a one to one dollar match to funds collected through a voluntary fee system administered by participating institutions. The participating institutions collect a voluntary fee of up to \$9 per student and submit a request to the State for a match of the total collected. The program gives students at participating institutions the opportunity to make contributions that will be used to meet the financial need of other students.

Bonus Incentive Grant awards are made to applicants redeeming Illinois College Savings Bonds who use at least 70% of the bond proceeds for higher education expenses. The grant is for \$20 for each year a bond is held, to a maximum of \$440. In 1997, the largest grants made were \$160 for eight-year-old bonds.

Kansas

All of the no-need programs (except Vocational Scholarship) carry service obligations in which the student must provide one year of employment in the field for which they received assistance for each year of scholarship assistance IN KANSAS. If recipient does not comply the scholarship converts to a 15% interest loan with interest accruing from date of funds release.

Louisiana

TAP awards to Louisiana residents who attend public colleges and who meet specific academic standards and financial need criteria, and who apply using the FAFSA by the state deadline.

Michigan

Appropriations and expenditures in the Competitive Scholarship Program (CSP) and the Tuition Grant Program (TGP) pose problems for statistical reports. Part I, Page 1, identifies appropriations and Part V identifies actual expenditures. Our TGP appropriation supplements awards in the CSP, so dollars paid out in CSP are higher than appropriation. The TGP dollars paid out are less than appropriation as the difference is paid to CSP recipients. When identifying increases or decreases in funding levels for states, Part I should be used.

Nevada

Nevada Student Access funding levels have increased significantly due to additional funding from the 1997 State Legislature. Nevada's State Legislature meets every 2 years.

New Jersey

During the 1996-97 academic year, NJOSA continued to refine operations to provide the greatest level of service possible to students, families and the financial aid community. A Grants and Scholarships Policy and Procedures Manual was distributed to the financial aid community which provides information relevant to NJOSA programs. NJOSA continued to enhance the electronic services provided to institutions and provided an increased level of training opportunities.

New York

Effective with the 1995-96 school year, students in 2-year programs (Associate Degree programs) are limited to three years of eligibility for State awards. Incarcerated students are no longer eligible for awards. Maximum awards at public universities and colleges were limited to 90% of tuition as compared to 100% in previous years.

Ohio

In December of 1996, administrative responsibility for Ohio's state-funded scholarship and grant programs was transferred back to the Ohio Board of Regents from the Ohio Student Aid Commission. The Regents previously administered these programs from 1970 to 1993. In addition to the core programs, the Regents assumed responsibility, in whole or in part, for several "specialized" programs, including Douglas, TELP and the Physicians' Loan Repayment Program.

Oregon

While expenditures in this program increased significantly over '95-96, it was not due to an increase in funding. Rather, it was the result of two things: (1) under-utilization in '95-96 and (2) reserve of state funding for expected loss of SSIG. Oregon's funding is provided on a biennial basis.

Pennsylvania

Level funding at the state level coupled with a decrease in Federal State Student Incentive Grant (SSIG) funds decreased the resources available to fund State Grants and this reduced the number of students who could be assisted by the program.

Rhode Island

The state appropriation was reduced by approximately \$1 million from the 1995-96 appropriation, but RIHEAA received a \$1 million transfer of funds from the Rhode Island Student Loan Authority, resulting in level funding. We continue to be one of the few states whose awards are fully portable.

South Carolina

In 1996-97, the state legislature appropriated \$20.760 million generated from low-level nuclear waste facility revenue for higher education scholarships, eventually to be divided 50%/50% between merit-based and need-based programs. Of the \$20.760 million, 18% was earmarked for in-state, independent college students (\$3.882 million) and 82% was earmarked for in-state public college students (\$16.878 million). For 1996-97, in-state, independent college student funds were divided \$2.984 million for need-based grants and \$830,000 for merit-based grants. In-state, public college student funds were divided \$4.6 million for need-based grants and \$2.270 million for merit-based grants.

Texas

The Hopwood decision (against affirmative action) rechanneled some of our funds from minorities to other students. The State Scholarship Program for Ethnic Recruitment and two minority scholarship programs in vocational and professional nursing were operated while dropping the ethnic criterion for selection of recipients (leaving need and academic performance as remaining criteria).

West Virginia

The 1996-97 academic year was the fourth year of a five-year funding improvement plan for the Program. Funding from general revenue was increased \$1.350 million. In addition, a \$3.0 million one-time allocation from surplus lottery funds was approved for the program. The Agency, with approval by the Advisory Council, elected to spend the funds over two years - \$1.5 million each year. Thus, 1996-97 growth totaled \$2.850 million.

Wisconsin

Awards are denied to those who are delinquent in court-ordered child support payments.

Wyoming

Decentralized system - no data maintained at Commission level.

Puerto Rico

Legislative Grant is the matching State source for SSIG. Funds are matched dollar per dollar. The supplementary AID Program is administered by the State University (University of Puerto Rico) and is therefore available only for UPR students.
