Executive Summary

The National Association of State Student Grant and Aid Programs (NASSGAP) is pleased to present its 31st Annual Survey Report of state-administered student financial aid available for the 1999-2000 academic year.

This year's report, the sixth compiled and published by the New York State Higher Education Services Corporation (HESC), offers information and statistics such as basic program information and expenditures, longitudinal indicators of student aid funding, and comparisons of student financial aid available in each of the 52 states and territories (Washington, D.C. and Puerto Rico included). The data and tables contained in the Report represent actual 1999-2000 academic year expenditure data (unless otherwise noted).

Federal funding of the Leveraging Educational Assistance Partnership (LEAP) Program (formerly known as the State Student Incentive Grant program), was held constant for the 1999-2000 academic year, following a decrease for the 1998-99 academic year. Federal funding for this program went from \$50 million in the 1997-1998 academic year to \$25 million in the 1998-1999 and 1999-2000 academic years, a \$25 million or 50% decrease. The LEAP program is a federal/state matching program to assist states in providing need-based grant aid to students to attend postsecondary education institutions.

In the 1999-2000 academic year, the states awarded \$4.089 billion in need and non-need-based student grant aid to

more than two and a half million students, an increase of 10.9% in expenditures over the \$3.686 billion awarded in 1998-1999. Of the amount awarded, 77.4% was need-based grant aid to undergraduate and graduate students, while 22.6% of it was non-need-based grant aid to undergraduates and graduates. These percentages show a slight change from the 81% and 19% awarded, respectively, in 1998-1999.
Funding for undergraduate need-based grant aid increased 6.5% in the 1999-2000 academic year over 1998-1999. This increase is slightly lower than the 6.6% one-year increase from 1997-1998 to 1998-1999.
Of the \$3.2 billion in need-based grant aid available, 99% went to undergraduates; and, of the \$0.9 billion in non-need-based grant aid awarded, 94% was awarded to undergraduates.
Seven states reported nine new need-based undergraduate grant programs and five states reported five new non-need-based undergraduate grant programs. See Report Notes, pages 80-83, for details.
Six states (California, Illinois, New Jersey, New York, Pennsylvania, and Minnesota) collectively awarded \$1.9 billion in undergraduate need-based grant aid, comprising 59% of the total awarded in this category.
Over the past five years, state spending (in current dollars) on need and non-need-based grant aid to undergraduate and graduate/professional students has increased 43.0% (see Table Two). From 1998-1999 to 1999-2000, 73% of the states (38) reported an increase in these categories, while 19% (10) reported a decrease, and 8% (4) reported no change.
Seventeen states reported an increase in need-based grant aid to undergraduates of more than 10% over 1998-1999. These states were Arkansas (+ \$9.09 million), California (+ \$38.15 million), Connecticut (+ \$3.89 million), Florida (+ \$8.23 million), Maine (+ \$2.66 million), Massachusetts (+ \$9.93 million), Mississippi (+ \$0.70 million), Missouri (+ \$4.10 million), Montana (+ \$1.52 million), Nebraska (+ \$0.95 million), North Carolina (+ \$4.49 million), Oregon (+ \$1.86 million), Puerto Rico (+ \$15.49 million), South Carolina (+ \$10.34 million), Texas (+ \$32.09 million), Utah (+ \$0.70 million), and West Virginia (+ \$3.03 million). Four states reported a decrease in funding of more than 10%. These states were Alabama (- \$0.22 million), Delaware (- \$0.44 million), Georgia (- \$0.47 million; eliminated all need-based undergraduate funding), and New Hampshire (- \$0.25 million). This compares to fourteen states reporting 10% or higher increases and nine states reporting 10% or lower decreases in the prior year. Three states, Alaska, Georgia, and South Dakota, no longer fund need-based undergraduate programs.

Reporting agencies administered over \$693 million in other aid (e.g., loan forgiveness, work-study, special purpose scholarships - see Table Three). States also reported awarding slightly more than \$1.0 billion in aid awarded by State agencies other than the primary student aid agency for the state. State designated federal student loan guaranty agencies also guaranteed \$22.9 billion in new federal loan volume – see Table Five.
Thirty states identified non-need-based state grant programs with a merit component. These merit-only programs constituted 22.8% of the total state grant aid available in these states in 1999-2000 (See Table Six A).
Twenty-one states identified need-based state grant programs with a merit component. These merit programs constituted 32.3% of the total state grant aid available in these states in 1999-2000 (See Table Six B).
Thirty-four states identified non-grant programs administered by the responding agency (e.g., loan forgiveness, work study, special purpose scholarships, etc.) with a merit component. These non-grant merit programs constituted 61% of the total non-grant aid administered by the responding agency that was available in these states in 1999-2000 (See Table Six C).
In total, through state grant and non-grant programs, responding agencies awarded \$1.389 billion through programs containing a merit component. This compares to \$3.450 billion awarded through programs with no merit component (see Tables One and Three).
Looking ahead to next year's report, states reported an estimated \$4.67 billion in appropriations for need and non-need student grants and scholarships for the 2000-2001 academic year.

Need-Based Undergraduate Grant Aid by State 1999-2000




Chart One Grant Aid Awarded by Responding Agencies 1999-2000




Chart Two Distribution of Need-Based Undergraduate Aid 1999-2000




Chart Three Actual 1994-1995, 1996-1997, & 1999-2000 Grant Aid Awarded

(In billions; current dollars, not adjusted for inflation)




Chart Four Federal SSIG/LEAP Funding Levels 1994-1995 to 2001-2002 Academic Years

(In millions; current dollars, not adjusted for inflation)



Connecticut

Over 85% of student aid appropriations in CT are allocated to CT colleges, which select grant recipients.

<u>Florida</u>

Eligibility renewal for scholarships & grants require students to meet renewal gpa & hours completion requirements.

Idaho

Idaho has few state aid programs administered by a central state agency. Most of Idaho's programs are decentralized.

Nevada

The Regents Award Program was established mid-year of 1997-98. Consequently, a substantial amount of money allocated for that award year was not spent and carried forward to 1998-99. The expenditures for the program in 1999-2000 match the appropriation for 1999-2000, hence the decrease from 1998-99.

New Hampshire

Increase in NHIP award was due to carryover funds from 1997-98.

New Jersey

As of 1999-2000, the administrative responsibility for the Minority Academic Careers Program was transferred to another state agency.

Vermont

VSAC is a comprehensive Student Assistance Agency that administers state grant programs, as well as being the guarantor and lender for federal student loans for Vermont students and non-resident students studying at Vermont institutions. VSAC also administers two statewide TRIO Programs in addition to a statewide GEARUP Program.

Washington

Four state student financial aid programs are authorized through budget provison only. Two new programs began in 1999-2000 (Washington Promise Scholarship and Masters in Education Reimbursement).

West Virginia

The 1999-2000 year marked the fifth consecutive year funding was increased by more than \$1 million. State funding has improved by \$8.9 million since 1994-95.

Wisconsin

Awards are denied to those who are delinquent in court ordered child support payments.
