Executive Summary

The National Association of State Student Grant and Aid Programs (NASSGAP) is pleased to present its 33rd Annual Survey Report of state-administered student financial aid available for the 2001-2002 academic year.

This year's report, the eighth compiled and published by the New York State Higher Education Services Corporation (HESC) on behalf of NASSGAP, offers information and statistics such as basic program information and expenditures, longitudinal indicators of student aid funding, and comparisons of student financial aid available in each of the 50 states, plus the District of Columbia and Puerto Rico. Unless otherwise noted, the data contained in the Report represent actual 2001-2002 academic year expenditures as reported by each state.

Student Aid Highlights

- In the 2001-2002 academic year, the states awarded about \$6 billion in total state funded student financial aid.
- The majority of state aid is in the form of grants with \$5.14 billion in need and non-need-based student grant aid going to more than 3.1 million students, an increase of 9.8% in expenditures over 2000-2001. Of the grants awarded, 75% was need-based aid to undergraduate and graduate students, while 25% was non-need-based grant aid to undergraduates and graduates. These percentages show almost no change from the 76% and 24% awarded, respectively, in 2000-2001.

Funding for undergraduate need-based grant aid increased 8.6% in the 2001-2002 academic year over 2000-2001, a smaller increase than the 12.4% one-year increase from 1999-2000 to 2000-2001.

Of the \$3.866 billion in need-based grant aid, 99% went to undergraduates; and, of the \$1.274 billion in non-need-based grant aid awarded, 95% was awarded to undergraduates.

Six states (California, Illinois, New Jersey, New York, Pennsylvania, and Texas) collectively awarded \$2.3 billion in undergraduate need-based grant aid, comprising about 60% of the total awarded in this category.

Tables 11 through 13 provide comparisons of state grant effort relative to various population measures. New York is the top state on all three tables in terms of providing need-based grant aid on a per capita basis. Georgia, however, takes over that position when all grant aid, including merit-based awards, is included.

- State student aid agencies administered over \$765 million in other non-grant aid, e.g., work-study, loan forgiveness, and special purpose scholarships - see Table Three.
- States also reported awarding more than \$421 million in aid administered by state agencies other than the primary student aid agency for the state. State designated federal student loan guaranty agencies also guaranteed \$28.3 billion in new federal loan volume – see Table Five.
- Seventeen states reported creating 27 new student aid programs.

Eight states (Georgia, Idaho, Missouri, North Carolina, New York, Puerto Rico, Texas, and Utah) reported eight new need-based grant programs.

Five states (Colorado, Idaho, Indiana, Mississippi, and Ohio) reported six new non-need-based grant programs.

Nine states (Colorado, Georgia, Maine, Mississippi, North Dakota, Oregon, Pennsylvania, Utah, and Virginia) reported thirteen new programs in the non-grant category. Eight of these are programs administered by the responding agency; five are programs administered by other state agencies or institutions.

- Over the past five years, state spending (in current dollars) on need and non-need-based grant aid to undergraduate and graduate/professional students has increased 66.36% (see Table Two). From 2000-2001 to 2001-2002, 77% of the states (40) reported an increase in these categories, while 21% (11) reported a decrease, and 2% (1) reported no change.
- Twenty states reported an increase in need-based grant aid to undergraduates of more than 10% over 2000-2001. These states were California (+ \$52.43 million), Colorado (+ \$4.82 million), District of Columbia (+ \$0.54 million), Delaware (+ \$0.15 million), Florida (+ \$9.46 million), Georgia (+ \$1.54 million), Idaho (+ \$0.12 million), Montana (+ \$0.61 million), North Carolina (+ \$13.13 million), North Dakota (+ \$0.62 million), Nebraska (+ \$1.40 million), New Hampshire (+ \$1.58 million), Ohio (+ \$13.66 million), Oklahoma (+ \$2.48 million), Tennessee (+ \$8.02 million), Texas (+ \$90.87 million), Utah (+ \$1.56), Washington (+ \$10.60 million), West Virginia (+ \$2.84 million), and Wyoming (+ \$0.16 million). Two states reported a decrease in funding of more than 10%. These states were Puerto Rico (- \$4.63 million) and South Carolina (- \$4.13 million). This compares to twenty-three states reporting 10% or higher increases and three states reporting 10% or higher decreases in the prior year. Two states, Alaska and South Dakota did not fund need-based undergraduate programs.
- Table Six provides information on student aid programs with a merit eligibility requirement.

Twenty-one states identified need-based state grant programs with a merit component. These merit programs constitute 39% of the total merit aid in 2001-2002.

Twenty-eight states identified non-need-based state grant programs with a merit component. These merit-only programs constitute 45% of the total merit aid available in 2001-2002.

Thirty-four states identified non-grant programs with a merit component (e.g., loan forgiveness, work-study, special purpose scholarships, etc.) that are administered by the responding agency. These non-grant merit programs constitute 16% of the total merit aid available in 2001-2002.

- In total, through state grant and non-grant programs, responding agencies awarded \$2.014 billion through programs containing a merit component. This compares to \$3.892 billion awarded through grant and non-grant programs with no merit component.
- Looking ahead to next year's report, states reported an estimated \$5.402 billion in appropriations for need and non-need based student grants and scholarships for the 2002-03 academic year, a 5% increase from 2001-2002.

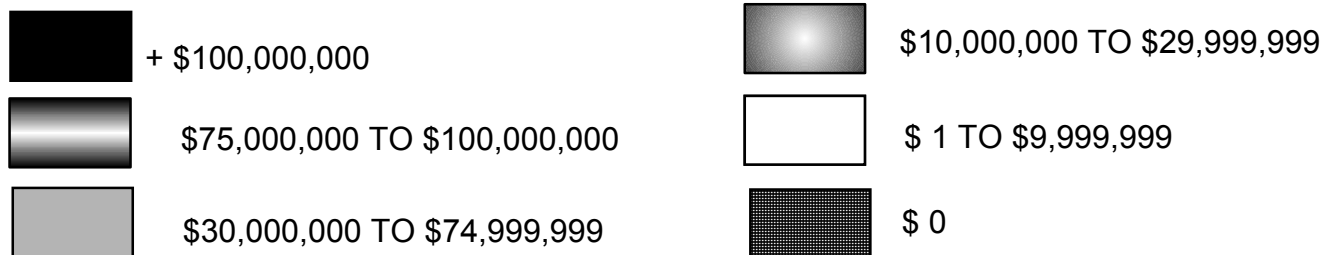
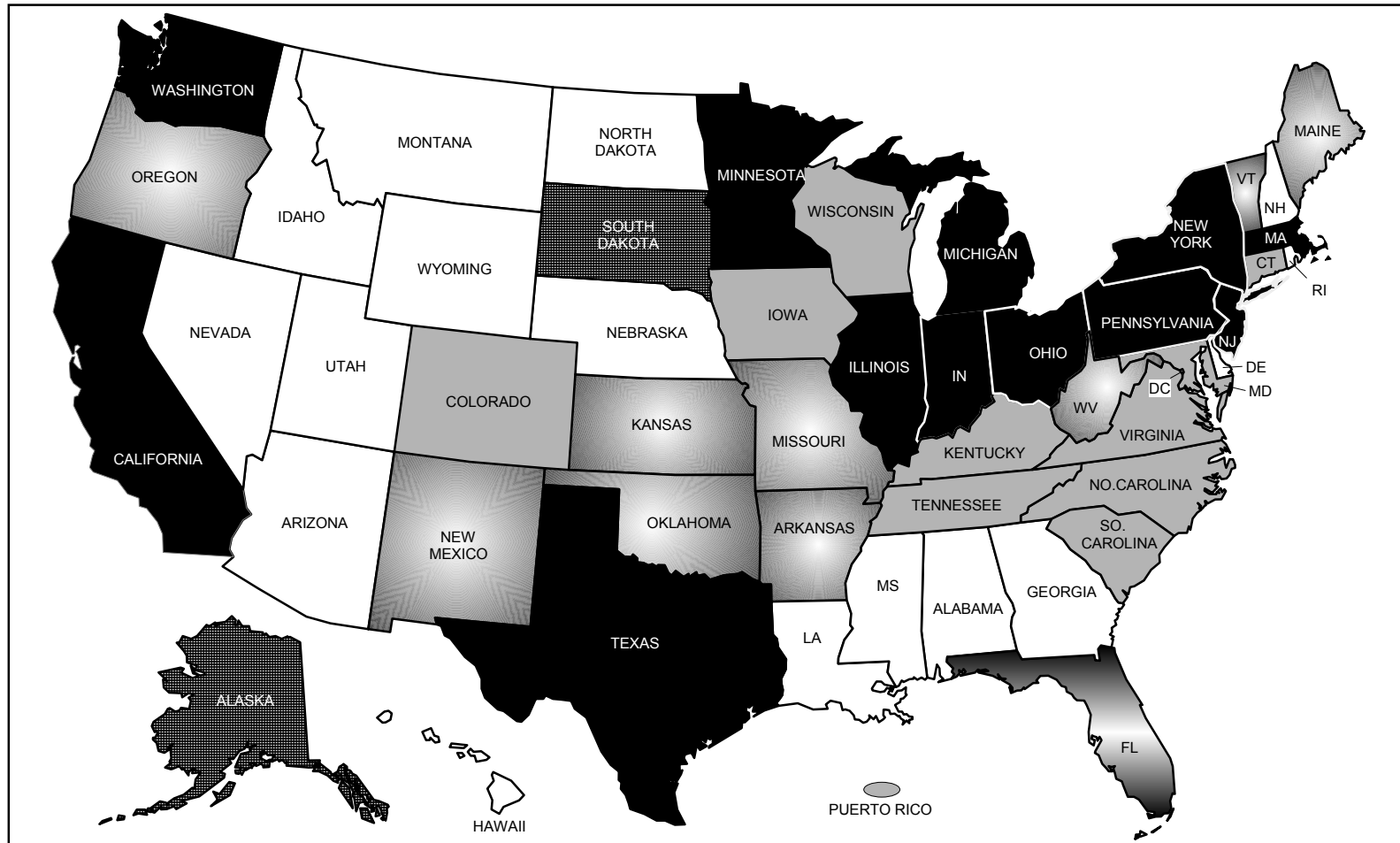


Chart One

2001-2002

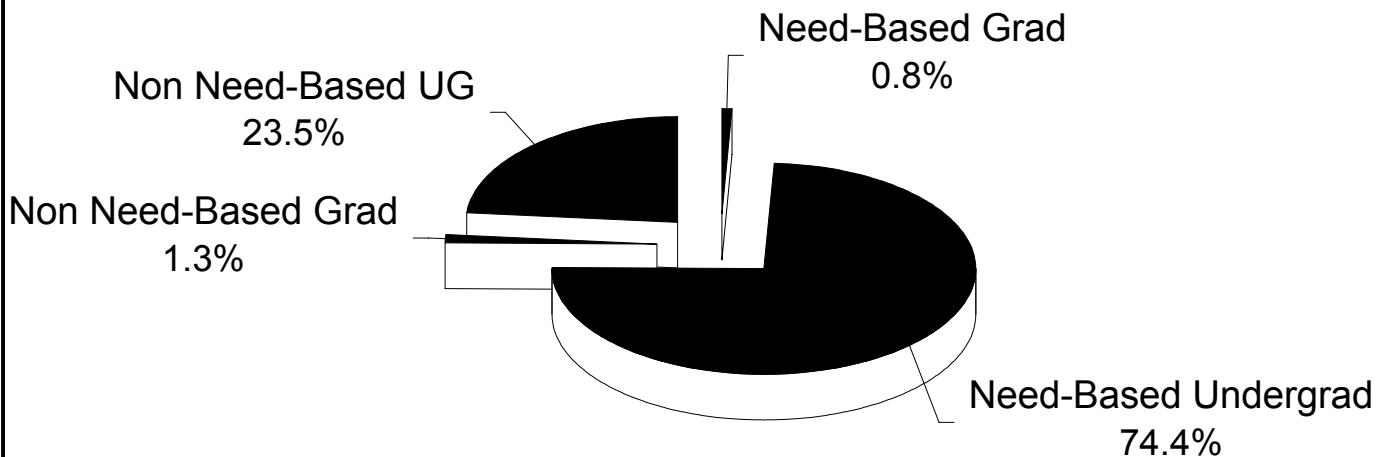


Chart Two

2001-2002

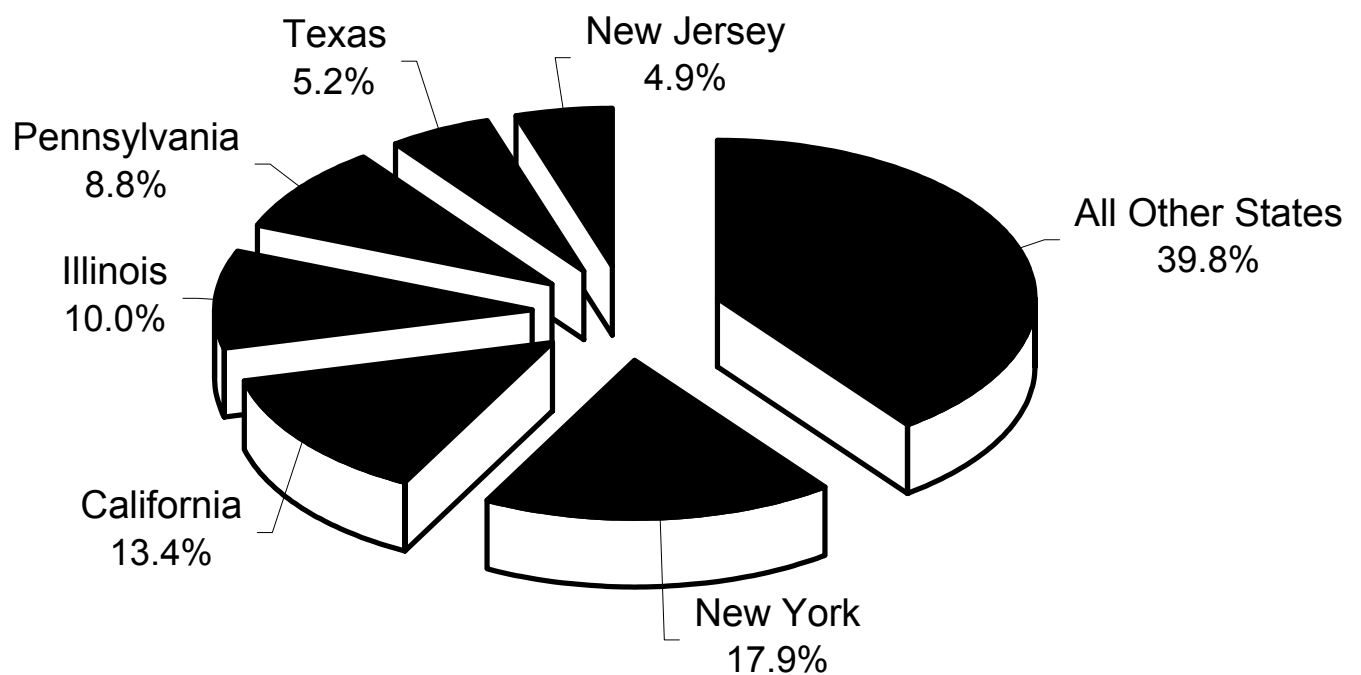

(In billions; current dollars, not adjusted for inflation)

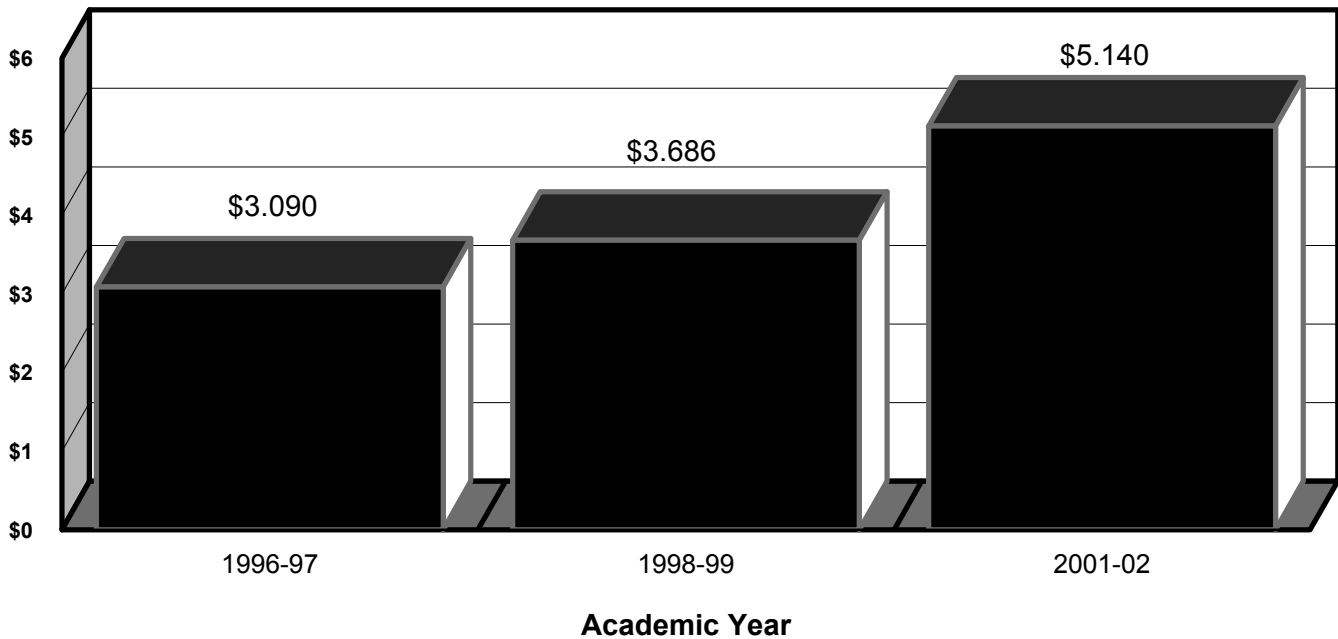
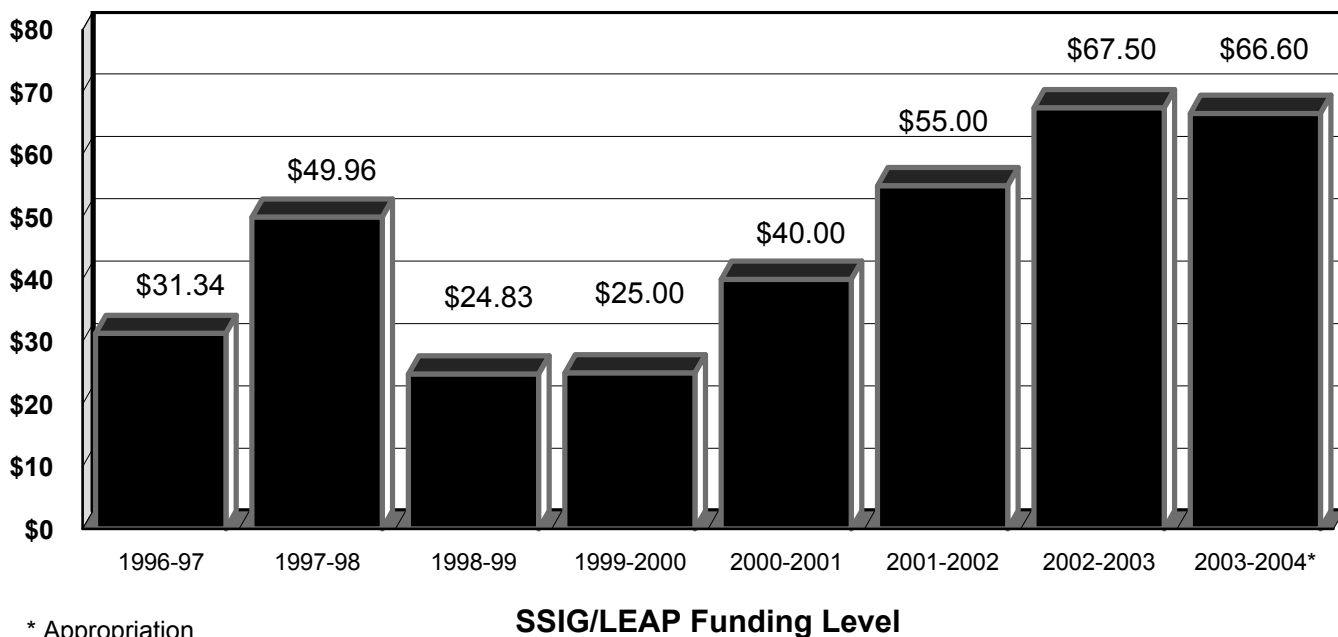

Individual State Grant Program Information, By State

Arizona

- The Arizona State Student Incentive Grant is now called the Arizona LEAP Program.

California

- *Cal Grant Programs.* California's state aid programs use the FAFSA data elements and basic federal calculations. The major Cal Grant program legislative changes implemented in 2001-02 require very technical and complex uses of various income and family size matrix data to ration additional "access" grants and all competitive grant awards. California is highly dependent on the existing FAFSA data and is concerned any time that the Department initiates a dialogue on FAFSA question reduction.
- *Cal Grant A* (need-based undergraduate; \$290,208,000). Legislation in 2000-2001 changed the Cal Grant Program. Cal Grant A Entitlement Awards provide grant funds to California residents who are recent high school graduates attending an approved California college or university offering undergraduate degree programs of at least two academic years. Cal Grant A Entitlement recipients must show financial need and meet a minimum 3.0 GPA requirements. A limited number of Competitive Cal Grant A awards are offered on a competitive basis to those students who do not meet entitlement program eligibility criteria.
- *Cal Grant B* (need-based undergraduate; \$205,240,000). Legislation in 2000-2001 changed the Cal Grant Program. Cal Grant B Entitlement Awards provide grant funds to California residents who are recent high school graduates attending an approved California college or university, show financial need and meet the minimum 2.0 GPA requirement. The first year award assists with living expenses and expenses for transportation, supplies and books. Beginning with the second year of attendance, the grant helps pay for tuition/fees. A limited number of Competitive Cal Grant B awards are offered on a competitive basis to those students who do not meet entitlement program eligibility criteria.
- *Cal Grant C* (need-based undergraduate; \$11,791,438). Awards are for California residents from low- and middle-income families who are enrolled in a California institution offering an occupational or vocational training program of at least four months in duration. The program must lead to a recognized degree or certificate.
- *Cal Grant T* (need-based undergraduate; \$ 6,741,000) Awards are for California residents who are teaching credential candidates with a baccalaureate degree and who attend a teacher credential program at an approved institution within California. Awards are for tuition/fees for a maximum of one academic year of full-time attendance. A recipient must teach for one year at a low-performing school for each \$2,000 of award money received, for a maximum period of four years.
- *Graduate Fellowships* (need-based graduate; \$23,000). This program was discontinued in 1998-1999. Only renewal students are funded.

Colorado

- *Colorado Extended Studies Grant* (need-based undergraduate). Funding for this program is rolled into other programs.
- *Colorado Leveraging Education Assistance Program (CLEAP)* (need-based undergraduate/graduate; \$1,453,458). This program was formerly called Colorado Student Incentive Grant.
- *Colorado Part Time Grant* (need-based undergraduate). Funds for this program are included in the Colorado Student Grant.
- *Governor's Opportunity Scholarship Program* (need-based undergraduate; \$5,958,127). This program has been previously unreported. This is a grant for highest need students.

- *Native American Tuition Funding* (non-need-based graduate; \$4,903,839). This program has been previously unreported. Under treaty with the U.S. government, Fort Lewis College provides free tuition to qualified Native Americans, both in and out-of-state.
- *Supplemental Leveraging Education Assistance Program* (need-based undergraduate; \$1,051,050). This program has been previously unreported. Federal funds are SLEAP funds; targeted for teacher education students to help reduce teacher shortage in CO.

Delaware

- *Critical Need Scholarship* (non-need-based undergraduate; \$31,202). Program objective is to support certification of teachers for shortage areas.
- *Michael C. Ferguson* (program type not available; \$534,000). This program has been previously unreported.

Florida

- *Florida Student Assistance Grants*. Eligibility renewal for scholarships and grants require students to meet renewal gpa and hours completion requirements.
- *Exceptional Student Education Training Grant for Out-of-Field Teachers* (non-need-based graduate; \$65,434). This program is based on number of credits, not recipients.
- *FL Nursing Scholarship program* (non-need-based undergraduate). This program was not administered by OSFA for the 2001-2002 academic year.
- *Instructional Aide/Critical Teacher Shortage Program* (non-need-based undergraduate/graduate; \$116,367). Number of awards is based on courses.
- *Limited Competitive Access Grant* (non-need-based undergraduate). This program was non-existent for the 2001-2002 academic year.
- *Nicaraguan and Haitian Scholarship* (non-need-based undergraduate). This program was not funded for the 2001-2002 academic year.
- *Occupational Therapy/Physical Therapy Tuition Reimbursement* (non-need-based graduate). This program was funded but there were no expenditures for the 2001-2002 academic year.
- *Postsecondary Education Planning Commission Student Member Scholarship* (non-need-based graduate). This agency is non-existent due to reorganization.
- *Student Regent Scholarship – State Board of Community Colleges* (non-need-based undergraduate). This program is no longer funded, as the agency no longer exists in statute.
- *Student Regent Scholarship – State Board of Regents* (non- need-based graduate). This program is no longer funded, as the agency no longer exists as identified in statute.

Georgia

- *Georgia's LEAP Grant Program* (need-based undergraduate; \$1,539,595). This is a new program.

Idaho

- Most programs decentralized.
- *Grow Your Own Teacher Scholarship* (non-need-based undergraduate; \$382,671). This is a new program. \$232,671 was expended for scholarships and \$150,000 supported faculty/mentors.
- *Idaho Leveraging Educational Assistance Partnership* (need-based undergraduate/graduate; \$705,669). Percentage of funding allocated to undergraduate and graduate levels is estimated.
- *Idaho Promise Category B Scholarship* (non-need-based undergraduate; \$3,234,075). This is a new program. Total expenditures include \$2,546,582 from the general fund appropriation and \$687,493 in matching institutional funds.
- *Public Safety Officer Dependent Scholarship* (non-need-based undergraduate; \$15,600). This program has been previously unreported. Scholarship covers fees, university housing and meal plan, books equipment and supplies for dependents of Idaho public safety officers killed or disabled in the line of duty.
- *State of Idaho Scholarship Program* (non-need-based undergraduate; \$244,301). Program name has been changed to the Idaho Promise Category A Scholarship.

Indiana

- *Fee Remission Program* (non-need-based undergraduate/graduate; \$10,933,439). This is a new program. Only available at public institutions for children of disabled veterans and children and spouses of police and firefighters killed in the line of duty.

Iowa

- *Accelerated Career Education Grants* (need-based undergraduate; \$144,397). The program has been previously unreported.

Kansas

- *Honors Academy* (need-based undergraduate; \$14,992). This is a pre-college high school program in which students attend university classes for credit and are eligible for financial assistance through this program, if they demonstrate need.
- *Kansas Comprehensive Grant* (need-based undergraduate; \$11,335,563). This program has been reported as three separate components of a larger program in prior years and is reported as one combined program this year.

Kentucky

- *College Access Program (CAP) Grant*. (need-based undergraduate; \$34,523,100). The CAP Grant maximum award amount is equal to the full-time tuition rate charged by community colleges. Awards were made to the first-listed school on the FAFSA; students must have notified KHEAA of a school choice change by August 1st for Fall and December 1st for Spring.
- *Kentucky Educational Excellence Scholarship* (non-need-based undergraduate; \$38,002,900). The Kentucky Educational Excellence Scholarship, authorized in 1999, is a merit-based scholarship program funded by Kentucky state lottery proceeds. High school students are eligible to earn college awards based on their GPA for each year of high school. The current data include the first cohort that was KEES-eligible for all four years of high school.

Louisiana

- *LA SSIG* (need-based undergraduate; \$1,451,570). Program is now called LA LEAP.
- *Tuition Opportunity Program for Students* (non-need based undergraduate, \$102,664,676.49) Beginning with the high school graduates of 2003, eligibility will be determined by the High School Grade Point Average calculated only on the TOPS Core Curriculum (16.5 specified college preparatory credits) of 2.5 instead of the cumulative High School Grade Point Average.

Massachusetts

- Similar to other states, Massachusetts experienced a reduction in funding for student financial aid programs due to the state and national economy. This reduction is expected to continue, at some level, in FY '03 and FY '04, with a rebound in FY '05.
- *Foster Child Grant* (need-based undergraduate; \$0.00). Initial FY 2002 appropriation of \$1,000,000 was rescinded in November 2001 to manage state revenue shortfall.
- *Mass. Cash Grant* (need-based undergraduate; \$34,330,565). FY 2002 appropriation reduced approximately 5% due to budget constraints.
- *MASS Grant* (need-based undergraduate; \$27,601,251). Initial FY 2002 appropriation was reduced by 20% in November 2001 due to revenue shortfalls.
- *Mass Part Time Grant* (need-based undergraduate; \$3,589,134). The FY 2002 program allocation was reduced by 10% due to budgetary constraints.
- *Tomorrow's Teachers Scholarship* (non-need-based/need-based undergraduate; \$3,854,436). SLEAP (listed as other funds) used to match scholarships for high need areas and high need students.

Minnesota

- The percentage of the State Grant budget the student is expected to pay, or Student Share, was decreased from 47 percent to 46 percent. The standard living cost allowance was raised from \$5,075 to \$5,405.

Missouri

- *Advantage Missouri Program* (Other Aid Awarded by Responding State Agency; \$1,375,662). This program is now reported in Table 3, Other Aid Available.
- *Bridge Scholarship Program* (need-based undergraduate). This program did not exist in the 2001-2002 academic year
- *Missouri Guarantee Plus Scholarship- GEARUP* (need-based undergraduate; \$32,938). This is a new program.

Montana

- *High School Honors Program* (non-need-based undergraduate/graduate; \$1,053,565). This program is being reported in Table Three, Other Aid Available - Aid Awarded by Other State Agencies, this year. It was reported in Table One last year. The funds for the program are provided by the colleges.
- We used the SLEAP funds to expand our MTAP program to include private 4-year colleges and tribal schools.

New Hampshire

- *New Hampshire Incentive Program* (need-based undergraduate; \$3,065,880). Increased in-state awards and made part-time students eligible.

New Jersey

- *Dana Christmas Scholarship for Heroism* (non-need-based undergraduate/graduate; \$10,000). The Dana Christmas Scholarship was established to honor the Seton Hall student who is credited with saving lives and helping many students avoid serious injury during the tragic fire on January 19, 2001.

Nevada

- *LEAP* (need-based undergraduate/graduate; \$290,336). Percentages used to calculate funding amounts to undergraduates and graduates are prior year.

New York

- *Memorial Scholarship for Children and Spouses of Deceased Police Officers/Firefighters* (non-need-based undergraduate; \$592,000). Program name has been changed to, "Memorial Scholarships for Families of Deceased Firefighters, Police Officers, Peace Officers and Emergency Medical Service Workers".
- *Vietnam Veterans Tuition Assistance* (non-need-based undergraduate/graduate; \$855,000). Program name has been changed to, "Vietnam/Persian Gulf Veterans Tuition Awards".
- *World Trade Center Memorial Scholarship* (need-based undergraduate; \$775,000). This is a new program.

North Carolina

- *Incentive Scholarships and Grant Programs for Native Americans* (need-based undergraduate/graduate; \$726,791). Percentage of funding allocated to undergraduate and graduate levels is estimated.
- *Tuition Remission* (non-need-based undergraduate/graduate; \$30,209,911). Percentage of funding allocated to undergraduate and graduate levels is estimated.
- *Teacher Assistant Scholarship Fund* (need-based undergraduate). This is a new program.

Ohio

- *Student Workforce Development Grant Program* (non-need-based undergraduate; \$1,200,000). The Student Workforce Development Grant program provides tuition assistance to students who attend private, for-profit proprietary institutions.
- We have empanelled a statewide Consultation to study the impact of current State financial aid investments on college access and success. It is our hope that the Consultation on Financial Aid

and College Costs will develop a set of recommendations in time for the next biennial budget deliberations.

Oklahoma

- *Academic Scholars* (non-need-based undergraduate/graduate; \$8,582,375). Percentage of funding allocated to undergraduate and graduate levels is estimated.
- *Minority Doctoral Study Grant* (non-need-based graduate; \$30,000). 2001-2002 is the final year that funds will be awarded under this program.
- *Minority Professional Study Grant* (non-need-based graduate). This program ceased operating at the end of the 2000-2001 academic year.

Oregon

- The State Grant Supplemental program (SGSA) was merged with the Opportunity Grant. This was a supplement to private college recipients in the Opportunity Grant. The merger allows the Commission, the Legislature, and other interested parties to focus on a single need-based program.
- *Supplemental Grant* (need-based undergraduate). This program was merged with the Opportunity Grant program starting in 2001-2002.
- *Oregon Opportunity Grant* (need-based undergraduate; \$19,865,916). The name of Need Grant Program changed to Opportunity Grant effective 2001-2002. SLEAP dollars are combined with reported LEAP.

Pennsylvania

- *PEGP*. This program is an education cost remission program. Schools must waive charges remaining after Pell and State grants are subtracted. No expenditure or recipient data is available for reporting.

Puerto Rico

Rhode Island

- *Texas Grant II* (need-based undergraduate; \$4,958,740). This is a new program. This grant is only available to students attending 2-year public institutions in Texas, including: public junior/community colleges, public technical colleges, and Lamar State College System institutions.
- *Texas New Horizons Scholarship* (need-based undergraduate; \$347,762). This program is in the process of being phased out.
- *Texas Nursing Scholarship* (need-based undergraduate/graduate; \$406,237). Percentage of funding allocated to undergraduate and graduate levels is estimated. This is an umbrella program covering programs for vocational and professional nursing at both the undergraduate and graduate level.
- *Texas Public Ed. - SSIG Program* (need-based undergraduate/graduate; \$2,324,283). Percentage of funding allocated to undergraduate and graduate levels is estimated.
- *Texas Tuition Equalization Grant* (need-based undergraduate/graduate; \$87,715,018). Percentage of funding allocated to undergraduate and graduate levels is estimated.

Utah

- The Utah State Student Incentive Grant has been renamed the Utah Leveraging Educational Assistance Partnership.

- *Wisconsin Higher Education Grant – WTC* (need-based undergraduate; \$14,157,863). Part-time undergrads included with full-time undergrads.
- *Wisconsin Tuition Grant* (need based undergraduate; \$21,141,847). Part-time undergrads included with full-time undergrads.

West Virginia

- The 2001-2002 year marks the seventh consecutive year that state funding improved by more than \$1 million. State funding has improved by \$13.7 million since 1994-95.

Wyoming

- *Leveraging Educational Assistance Program (LEAP)* (need-based undergraduate; \$162,788). The State of Wyoming has participated in the LEAP (formerly SSIG) program since 1977; however, the Legislature did not appropriate any State funds for the program for the 2000-01 Award Year so there was no information reported for that period.
