Executive Summary

The current air of uncertainty surrounding the reauthorization of the Higher Education Act and the concerns of many regarding the future of federal budget outlays for key student students and programs highlight the importance of the continuing commitment by states to helping students access the postsecondary education of their choice. State efforts, in close partnership with federal and privately funded aid, ensure students are able to attend, and succeed in, college.

This report provides data regarding state-funded expenditures for student financial aid and illustrates the importance of efforts made by the states to assist postsecondary students. Information in this report is based on academic year 2003-2004 data from the 35th Annual National Association of State Student Grant and Aid Programs (NASSGAP) survey of state expenditures for student financial aid.

Data Highlights

- In the 2003-2004 academic year, the states awarded about \$7.3 billion in total state funded student financial aid, an increase of more than 6 percent in nominal terms from the \$6.9 billion in aid awarded in 2002-2003 and an increase of about 4 percent in constant dollar terms.
- The majority of state aid is in the form of grants. In 2003-04 almost 3.4 million awards were made representing about \$6.2 billion in need and nonneed-based grant aid, an increase of close to 7 percent from the \$5.8 billion in grants awarded in 2002-2003. Of the grant funds awarded in 2003-04, 74 percent was need-based and 26 percent was nonneed-based. Need-based aid represented about 73 percent of grant aid awarded in 2002-03.
- Funding for undergraduate need-based grant aid increased \$290 million nationwide from slightly less than \$4 billion in 2002-03 to more than \$4.2 billion in 2003-04, an increase of almost 7 percent.
- Seven states (California, Illinois, Indiana, New Jersey, New York, Pennsylvania, and Texas) collectively awarded more than \$2.7 billion in undergraduate need-based grant aid, accounting for about 64 percent of all aid of this type.
- States provided about \$1.2 billion in nongrant student aid, including loans, loan assumptions, conditional grants, work-study, and tuition waivers. Loans and tuition waivers accounted for 63 percent of nongrant funds awarded.

Forty-three reporting entities identified state-funded undergraduate programs with awards based solely on need, while 23 identified programs with awards based only on merit. Exclusively need-based aid constituted 51 percent of all aid to undergraduates, exclusively merit-based aid accounted for 17 percent, with the rest, 32 percent, accounted for by other programs and by programs with both need and merit components. The amount of undergraduate aid awarded in 2003-04 through programs with a merit component increased from slightly more than \$1.8 billion to about \$2 billion. This compares to \$3.2 billion awarded to undergraduates through programs based only on need.

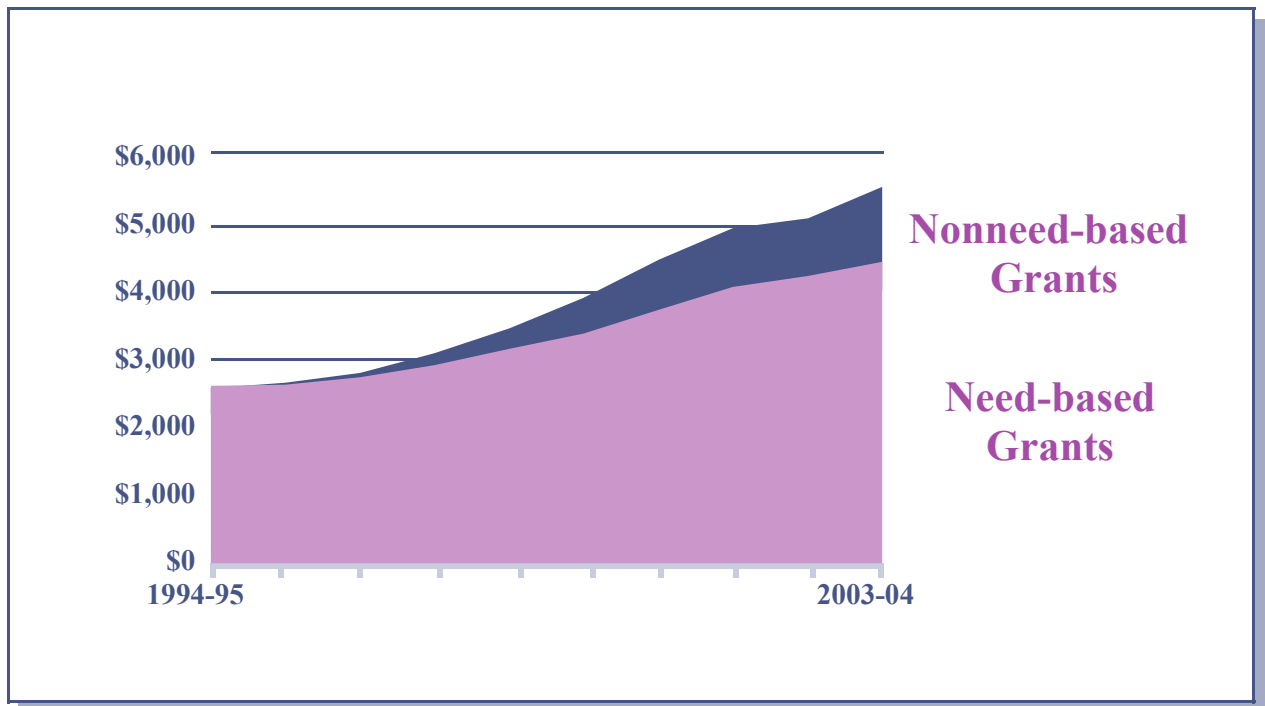
South Carolina, Washington DC, Georgia, New York, and Indiana, provided the greatest amount of grant aid on a per capita basis and the largest amount of aid per capita for the population between ages 18 and 24. Georgia, South Carolina, New York, New Jersey, and Kentucky provided the most undergraduate grant dollars compared to undergraduate full time equivalent enrollment. Georgia, South Carolina, Vermont, New York, and Pennsylvania had the highest proportion of total expenditures for state-funded grants compared to appropriations for higher education operating expenditures.

Constant dollars provide a method of comparing expenditures across years and adjusting for the effect of inflation. Constant dollars were calculated using the academic year correction of the Consumer Price Index, All Urban Consumers (CPI-U) from the U.S. Department of Labor, Bureau of Labor Statistics.

Need-based Undergraduate Grant Aid, by State: 2003-04

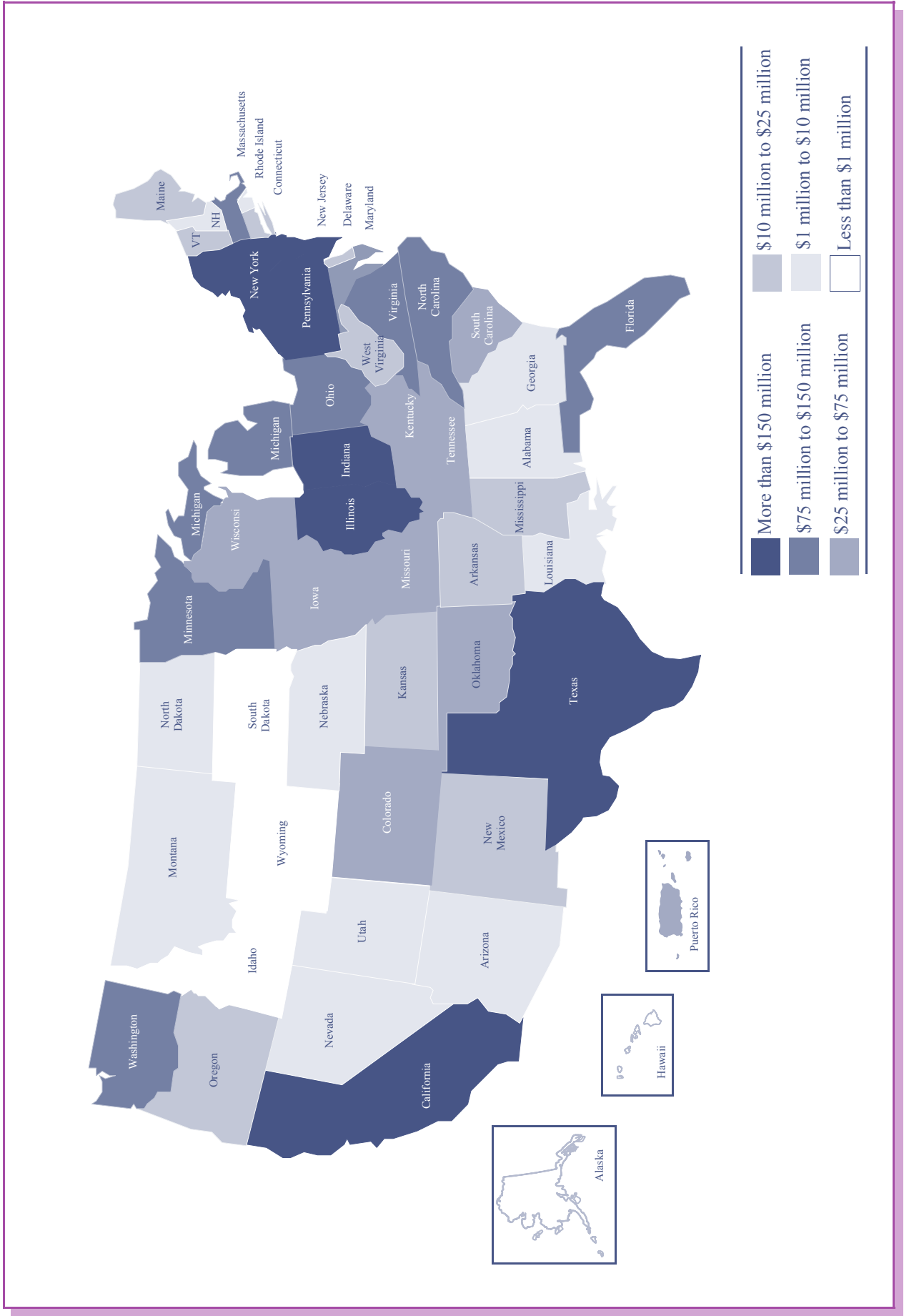

Figure 1. Undergraduate Aid Dollars, by Type of Aid: 2003-04

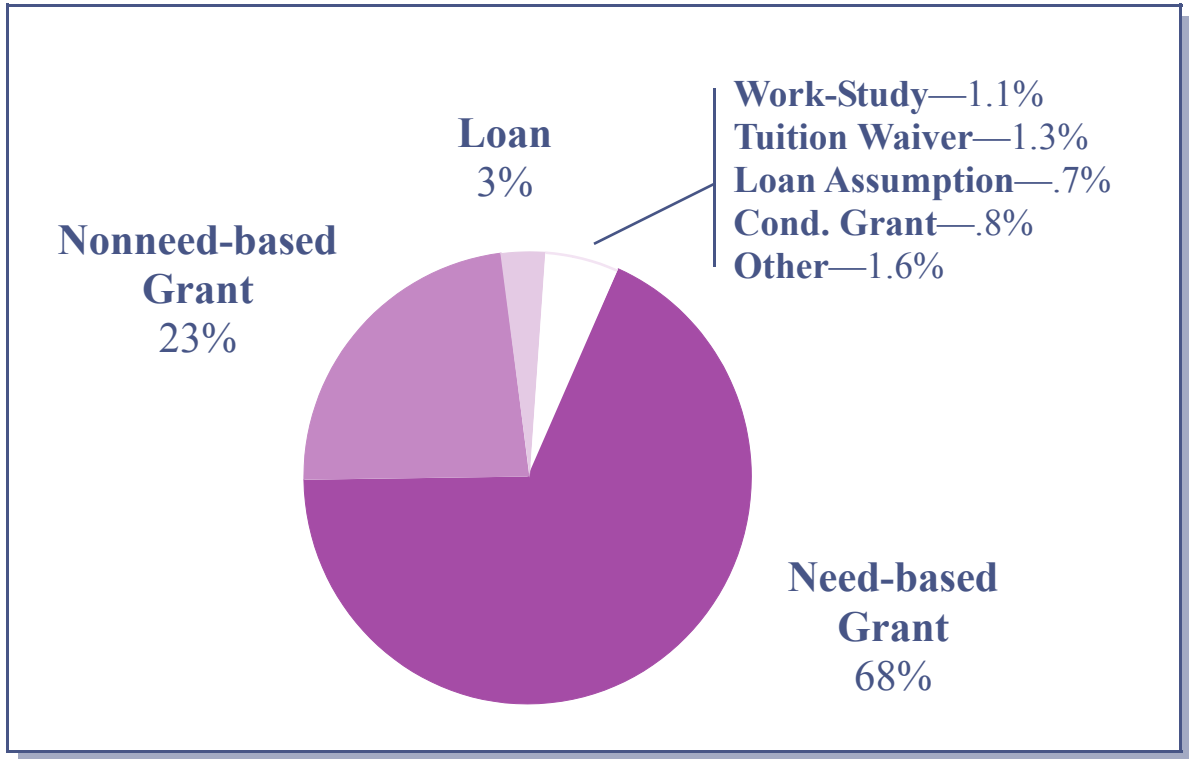


Figure 2. Graduate Aid Dollars, by Type of Aid: 2003-04

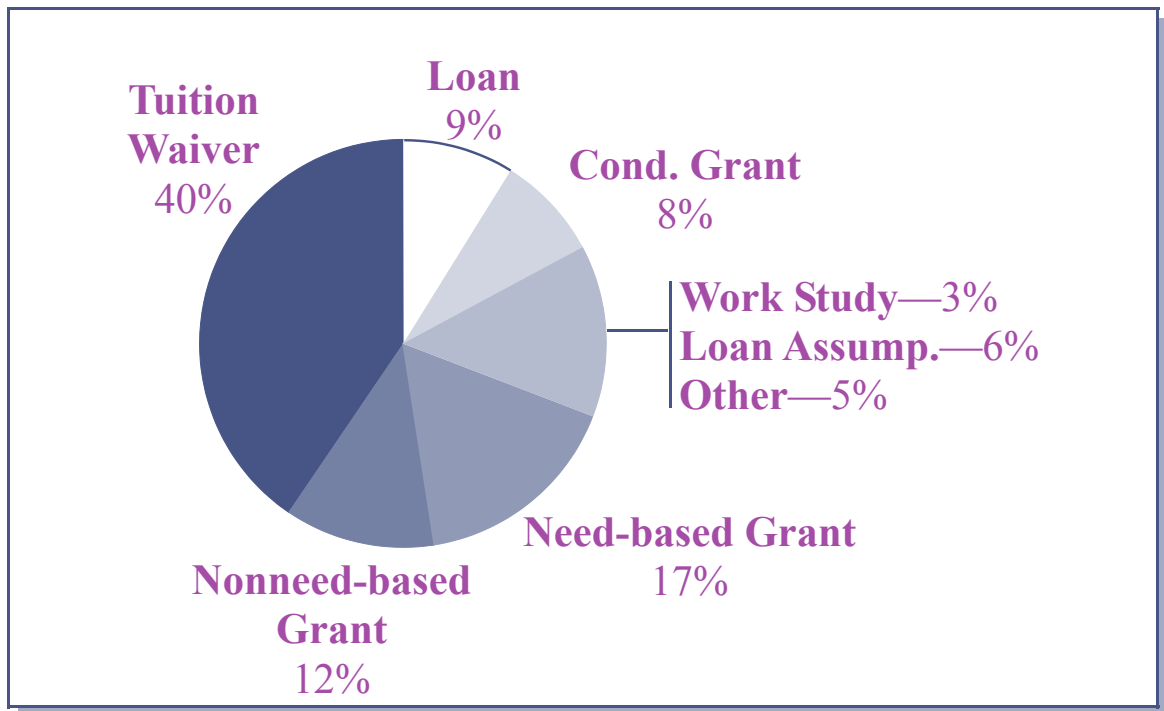


Figure 3. Undergraduate Aid, by Standard for Award: 2003-04

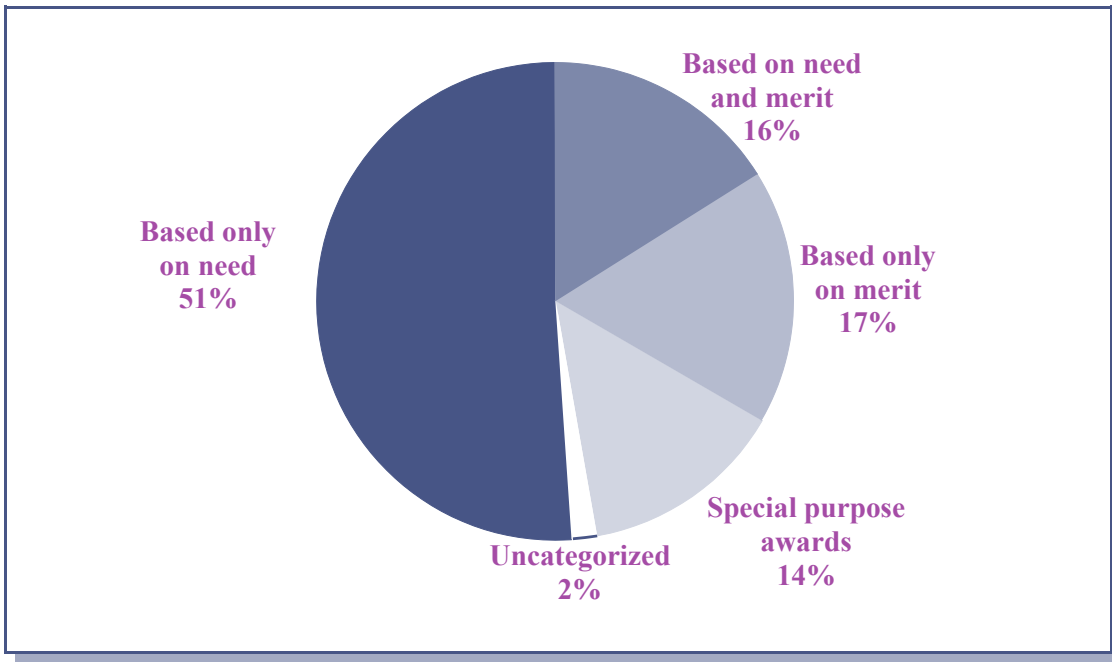


Figure 4. Undergraduate Aid with a Merit Component, in Constant 2003-04 Dollars (in millions of dollars): 1999-2000 through 2003-04

Figure 5. Need-based Undergraduate Grant Aid by State: 2003-04

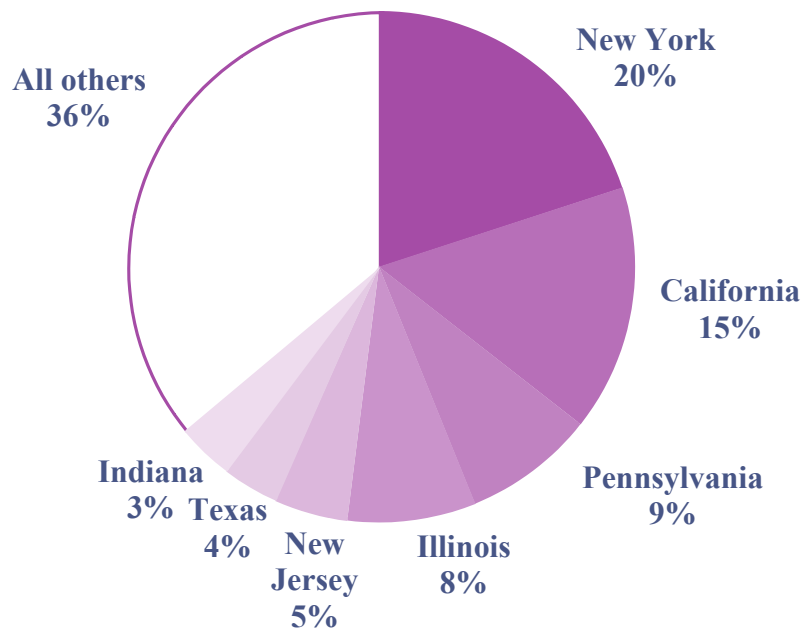


Figure 6. Need-based Undergraduate Grant Aid per Full-Time Equivalent Enrollment, by State: 2003-04

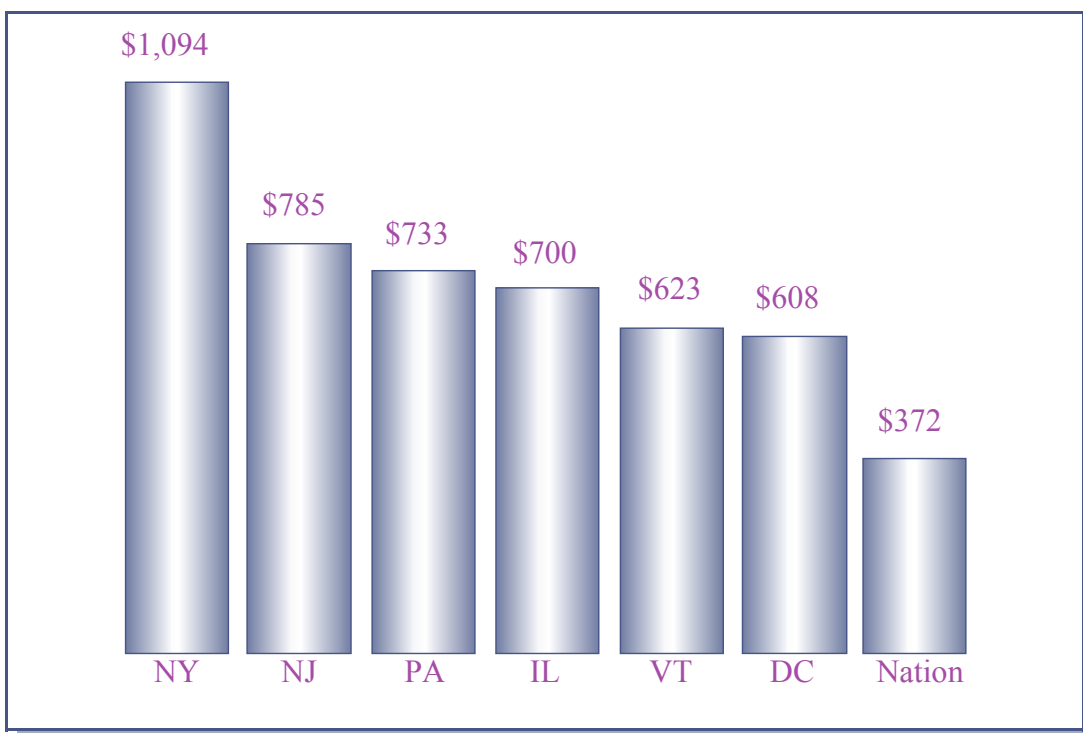

About the Survey

The 35th Annual NASSGAP survey was completed by each state in Winter 2003-04. A PDF version of the survey instrument is available at www.nassgap.org/survey/NASSGAP_Survey_Instrument_2003-04.pdf. Terms used on the survey instrument include:

Grant aid: Includes grants, scholarships and other such gift aid.

Need-based aid: Recipients must meet some standard of need using such measures as EFC, remaining costs, or maximum income to be eligible for an award.

Nonneed-based aid: Recipients are not required to demonstrate financial need to be eligible for an award.

Merit based aid: Recipients are selected in whole or in part on the basis of test score, performance, class rank, grade point average, or other such criteria of achievement.

Primary need-based grant program: The flagship need-based grant program in a state. For some states (California, Colorado, Florida, South Carolina), the primary need-based grant program may be a combination of several individual programs.

Tuition waiver program: Program mandated or funded by a state in which all or a portion of a recipient's tuition at an eligible institution is not charged to the award recipient.

Loan assumption or forgiveness program: Program in which a recipient has the possibility of having a loan repaid or forgiven, in whole or in part, in exchange for fulfilling certain service obligations.

Conditional grant or loan program: Recipient receives an award, which will become a loan if certain obligations are not met.

Special purpose program: Program with specific objectives usually targeted to specific groups of students. Examples include workforce development programs in which recipients train for particular occupations, such as teachers and health and technical workers; retraining programs aimed at retraining unemployed workers; post-service programs offering benefits to veterans or National Guard members; and, parent or spouse service programs providing benefits to spouses or children of persons killed or disabled during service to the National Guard, police, fire fighters, military, corrections system, or other occupations.
