Puerto Rico did not respond to the survey this year. There was insufficient information available to estimate Puerto Rico's aid expenditures. Puerto Rico is unlikely to continue reporting moving forward.

# Executive Summary

This report provides data regarding state-funded expenditures for student financial aid and illustrates the extent of efforts made by the states to assist postsecondary students. Information in this report is based on academic year 2020-21 data from the 52nd Annual NASSGAP survey.

## Data Highlights

- In the 2020-21 academic year, the states awarded almost \$14.8 billion in total state funded student financial aid, a slight decrease about 0.1 percent in nominal terms and about 1.3 percent in constant dollar terms from the \$14.8 billion in aid awarded in 2019-20.
- The majority of state aid (87 percent) remains in the form of grants. In 2020-21, about 4.1 million grant awards were made representing about 12.9 billion in need and nonneed-based grant aid. This represents a decrease of about 0.4 percent from the \$12.95 billion in grants awarded in 2019-20. Of the grant money awarded in 2020-21, about 73 percent was need-based and about 27 percent was nonneed-based, a breakout consistent with historical data.
- Funding for undergraduate need-based grant aid decreased slightly nationwide from \$9.3 billion in 2019-20 to about \$9.15 billion in 2020-21, a change of about 1.8 percent in nominal terms.
- Eight states (California, Texas, New York, Washington, New Jersey, Virginia, Illinois, Pennsylvania) collectively again awarded about 6.3 billion in undergraduate need-based grant aid, accounting for about 69 percent of all aid of this type.
- States provided about \$1.8 billion in nongrant student aid, including loans, loan assumptions, conditional grants, work-study, and tuition waivers. Tuition waivers represented about 51 percent of nongrant aid.

Most states reported state-funded undergraduate grant program with a need component, however, Wyoming reported no need-based aid programs. Puerto Rico did not report any data this year and is unlikely to continue reporting moving forward. Twenty-four states identified undergraduate programs which made awards based only on merit. Exclusively need-based aid constituted 45.9 percent of all aid to undergraduates, exclusively merit-based aid accounted for 20.9 percent, with the rest, 33.2 percent, accounted for by other programs and by programs with both need and merit components.

South Carolina, Georgia, Louisiana, Virginia, and Washington provided the greatest amount of grant aid on a per capita basis. South Carolina, Georgia, Washington, Louisiana, and Tennessee provided the most undergraduate grant dollars compared to undergraduate full time equivalent enrollment. Excluding Washington D.C., South Carolina, Louisiana, Colorado, Virginia, and Georgia had the highest proportion of total expenditures for state-funded grants compared to State fiscal support for higher education. The figures in this survey should not include any Federal stimulus funds.






**Figure 1. Undergraduate Aid Dollars, by Type of Aid: 2020-21**




**Figure 2. Graduate Aid Dollars, by Type of Aid: 2020-21**




